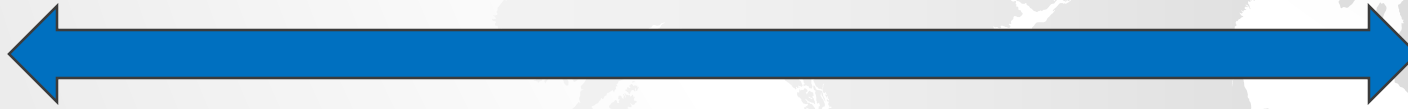

LIBERAL VS. CONSERVATIVE: THE SOVEREIGNTY VIEW

- The liberal believes in the sovereignty of a social construct
 - Each individual is born into a social construct, and is entitled to only those rights conferred by that social construct.
 - The individual owes allegiance to the social construct and equally to all of the other members of that social construct.
 - Social constructs are variable, and can be re-defined at will and as circumstances dictate.
 - Man is fundamentally good, and external forces result in evil behavior that is not his fault.
- The conservative believes in the sovereignty of the individual
 - Each individual is a unique creation of God, and is endowed with unalienable rights.
 - The individual owes allegiance only to God, unless he or she willingly decides to subjugate a portion of their own sovereignty to society.
 - The will of God is invariable, and does not change due to social circumstances.
 - Man is fundamentally sinful, and must constantly struggle to become good.

LIBERAL VS. CONSERVATIVE THINKING

- Liberals base their political belief systems on “common thought”, and do not study, rationalize, or understand the bases for their beliefs. Consequently, their political belief systems are often in conflict with their personal belief systems, if they in fact are able to articulate their personal belief systems.
- Because of this, liberals tend to follow “group think”, and rigidly adhere to the party line and arguments.
- Conservatives base their political belief systems on rational thought built upon foundational moral principles that are part of their personal belief systems.
- Because of this, conservatives tend to be independent thinkers, and have difficulty in developing a unified approach to problem solving.

LIBERAL VS. CONSERVATIVE THINKING

- Liberals believe in pursuing policies because they're "nice" and make them feel good. Whether the policies they're advocating actually work or not is of secondary importance to them.
- Conservatives believe in pursuing policies because they're pragmatic and because they work.

LIBERAL VS. CONSERVATIVE THINKING

- Liberals, most of them anyway, are hostile to Christianity. That's why, whether you're talking about a school play at Christmas time, a judge putting the Ten Commandments on the wall of his court, or a store employee saying "Merry Christmas" instead of "Happy Holidays," liberals are dedicated to driving reminders of Christianity from polite society.

- Conservatives, most of them anyway, believe in God and think that the Constitution has been twisted by liberal judges to illegitimately try to purge Christianity from the public square. We also believe, most of us anyway, that this country has been successful in large part because it is a good, Christian nation and if our country ever turns away from the Lord, it will cease to prosper.

LIBERAL VS. CONSERVATIVE THINKING

- Liberals are internationalists who are more concerned about what Europeans think of us and staying in the good graces of the corrupt bureaucrats who control the UN than looking out for the best interests of this nation.
- Conservatives are patriotic, believe that America is a great nation, and are primarily interested in looking out for the good of the country. That's why we believe in "American exceptionalism" and "America first."

LIBERAL VS. CONSERVATIVE THINKING

- Liberals think that the solution to every problem is another government program. Even when those new programs create new problems, often worse than the ones that were being fixed in the first place, the solution is always....you guessed it, another government program.
- Conservatives believe that government, by its very nature, tends to be inefficient, incompetent, wasteful, and power hungry. That's why we believe that the government that governs least, governs best.

LIBERAL VS. CONSERVATIVE THINKING

- Liberals, and Democrats for that matter, believe in big government, high taxes, and they have never met a new spending program they didn't like, whether we will have to go into debt to pay for it or not.
- Conservatives, but not necessarily Republicans (which is unfortunate), believe it's vitally important to the future of the country to reduce the size of government, keep taxes low, balance the budget, and get this country out of debt.

LIBERAL VS. CONSERVATIVE THINKING

- Liberals believe in using law enforcement measures to deal with terrorism, which means that they feel we should allow terrorists to train, plan, and actually attempt to kill Americans before we try to arrest them -- as if you can just send the police around to pick up a terrorist mastermind hiding in Iran or the wilds of Pakistan.
- Conservatives believe in confronting and defeating enemies of the United States before they can harm American citizens.

LIBERAL VS. CONSERVATIVE THINKING

- Most liberals, despite what they'll tell you, believe that abortion ends the life of an innocent child, but they prefer killing the baby to inconveniencing the mother.
- Conservatives believe that abortion ends the life of an innocent child and since we believe that infanticide is wrong, we oppose abortion.

LIBERAL VS. CONSERVATIVE THINKING

- Liberals are socialists who view successful business owners as people who cheated the system somehow or got lucky. That's why they don't respect high achievers and see them as little more than piggy banks for their programs.
- Conservatives are capitalists and believe that entrepreneurs who amass great wealth through their own efforts are good for the country and shouldn't be punished for being successful

LIBERAL VS. CONSERVATIVE THINKING

- Liberals believe that it's ok to discriminate based on race as long as it primarily benefits minority groups.
- Conservatives believe that we should live in a color blind society where every individual is judged on the content of his character and the merits of his actions.

LIBERAL VS. CONSERVATIVE THINKING

- Liberals believe by taking arms away from law abiding citizens, they can prevent criminals, who aren't going to abide by gun control laws, from using guns in the commission of crimes.
- Conservatives believe that individual Americans have a right to defend themselves and their families with guns and that right cannot be taken away by any method short of a Constitutional Amendment, which conservatives would oppose.

THE TEA PARTY AND THE REPUBLICAN PARTY

- Did the election of President Obama spell the end of the Republican Party, as was promised?
- YES: The reign of traditional Republicanism (as polluted by money and corruption) did come to an end as the people rose up in rejection of RINO politicians who would not stand behind conservative principles.
- NO: A new wave of conservatism began to replace the old Republicans with a new breed of conservative Republican at the Federal and the State levels.
- OUTCOME: The Republican Party was not marked by its demise, but rather by its rebirth. Conservative ideals remained strong in the minds of the believers, and brought forth a birth of a new conservatism.

NATIONAL POPULISM AND THE DEMOCRATIC PARTY

- Will the election of President Trump spell the end of the Democratic Party, or more generally, the end of Liberalism?
- YES: Rather than coming together to develop a strategy, Democrats have participated in Trump Derangement Syndrome, over-reacting without meaning in an attempt to de-legitimize the Trump presidency.
- NO: Eventually, the powers that drive the liberal / progressive causes will begin to formulate strategic approaches that will enable their followers to have a common theme to get behind. Once established, the people will quickly fall into line behind it.
- OUTCOME: The Democratic Party has been damaged by its inability to create and sustain clear and consistent ideals that define it. Hence, its followers have become fragmented as the party tried to find common ground. Special interests have prevailed over a common purpose, and there are no consistent liberal ideals that can survive on their own.

DRIVERS OF LIBERALISM

- Policies that are created to support the common good of a broad range of society; equality; fairness; protection under the law.
- Policies that are aimed at caring for the most susceptible of the population.
- Equality of outcomes as opposed to equality of opportunity.
- Celebration of diversity; not only tolerance of differences, but the celebration, acceptance, and incorporation of those differences into the broader culture.
- Multi-culturalism and the retention and celebration of differences.
- Humanism and the replacement of morality with situational ethics

METHODS OF LIBERALISM

- Create the narrative to support the objective, rather than establish objectives to support principles.
- Attack, minimize, and destroy opposing views. Create division on all fronts to prevent defensive responses.
- Create dependency on the government and liberal entities
- Focus the use of money to drive liberal policies, organizations, and activities.
- Disinformation to destroy the truth and to create alternative truths that support the liberal cause.
- Social disruption and chaos, destroying the system from within.

OBJECTIVES OF LIBERALISM

- To destroy the sovereignty of the individual and create a dependency on the government and liberal organizations.
- To create the planned society; liberal leaders believe that only they have the intelligence to manage society.
- Power and wealth

HOW LIBERALISM DIED

- Over-reach: by pushing too hard and too far on too many fronts, liberals no longer understood what to believe in. Without clear political direction or moral compass, liberals began to fragment.
- Resistance vs. opposition: liberals no longer stand in opposition to a different set of beliefs, but have been driven into irrational resistance, as if of a despotic government.
- Lack of coherence: too many attacks on too many fronts causes confusion and uncertainty on what to believe. While the power structure believes that they are leading, the liberal base has been left behind.
- Assaults on the fundamental freedoms and beliefs of the average liberal.
- Violence and disruption without objective has resulted in the disenfranchisement of the moderate liberal.

WHAT'S NEXT?

- The new incarnation of the liberal: what will it be? The further it pushes left, the smaller the base will become. Will the liberal movement realize the risk and return more to the center, or will it continue to push left until it implodes?
- What do we expect to see? More and more radical shifts to the left and increased assaults on the right in order to discredit their beliefs and actions. The use of massive media engines to create uncertainty and distort the truth.
- How should we be prepared? Awareness of the actions and the consequences. The thunder and fury of the left is not indicative of a movement as much as it is an effort to create a movement.
